# I) Chair's Report and "Voluntary Improvement Plan" (VIP) Update

The Miami River Commission unanimously adopted their October public meeting minutes.

MRC Chairman Aguirre provided the following report:

The free 26th Annual Miami Riverday will be held April 5, 2025, 1-6 PM, Lummus Park, 250 NW North River Drive, featuring free boat rides, live music, environmental education, historic reenactors, children's activities, food and drinks. Sponsorships are available with Brett.

In addition, advertisements are available for the 22nd Annual Miami River Map and Guide.

The long Planning Development and Engineering (PD&E) process to design a new 17 Ave Bridge is having its 1<sup>st</sup> public meeting on November 12, 6:30 PM, 2300 NW 14 ST, next door to Ronald Reagan Park on the South Fork Tributary.

The MRC thanked Gus Barrera for serving as the designee for the Greater Miami Chamber of Commerce (GMCC), and welcomed the GMCC's new designee Tere Garcia.

## II. Discussion Regarding Fort Dallas Park

The MRC's March 4, 2024 public meeting minutes were distributed stating:

"Richard Heisenbottle, R.J. Heisenbottle Architects, presented the "City of Miami, Office of Capital Improvements, Flagler Workers House (Palm Cottage) Restoration – Construction Documentation Progress Set 12-10-23", featuring a depiction of the restored historic structure constructed in 1897 is on the National Register of Historic Places and currently in need of restoration. In addition, the City will demolish the 2 non-historic structures on the site

The Miami River Commission (MRC) unanimously agreed to continue supporting the expedited restoration of the historically designated Flagler Workers House, reconstruction the public Riverwalk, and reopening Fort Dallas Park."

Hector Badia, City of Miami Capital Improvements Department, stated the City was ready to commence demolition of the site's non-historic buildings. Richard Heisenbottle stated the plans were complete to restore the historically designated Flagler Workers House, and Mr. Badia added the restoration work is estimated to commence in August 2025. Theo Long asked what after the historic house is restored, what use will it serve? Mr. Mora, Assistant Director of the City of Miami's Parks Department, suggested a conversation regarding future uses needs to occur with the City Manager Art Noriega and the Parks Director Chris Evans. Spencer Crowley suggested repairing the site's dock damaged in Hurricane Irma, and consider using it and the historic structure for the City of Miami Marine Patrol and Police Department. Mr. Crowley stated he will provide pictures of a historic house on the Fort Lauderdale Riverwalk.

## III. Discussion Regarding Sewell Park

The MRC's May 6, 2024 public meeting minutes were distributed stating:

"Keith Ng, City of Miami's Office of Capital Improvements (OCI) presented plans, awarded FIND Phase 1 Grant Application, and Miami-Dade County DERM letter essentially denying the City of Miami's presented plan because it includes a boat slip for marine patrol and 5 transient boat slips which although would be allowed if the site was zoned residential, since its zoned Parks and Recreation the slips are not allowed under the current Manatee Protection Plan.

Commissioner Gabela stated support for the City of Miami's current plans to improve Sewell Park.

The MRC adopted a resolution 13-1 to support the City of Miam's plans to improve Sewell Park and send a letter to Miami-Dade County urging the Board of County Commissioners to amend the manatee protection plan to regulate transitory boat slips in the same fashion as Palm Beach."

Hector Badia, City of Miami Capital Improvements Department, stated on November 1 the City of Miami sent DERM a letter appealing the permit denial, etc. Mr. Badia stated the City of Miami is hosting a pubic meeting regarding the City's completed Master Plan of improvements to Sewell Park, including the Conservation area, on November 12 in Sewell Park, 1815 NW South River Drive. Mr. Badia stated the planned improvements are estimated to cost \$12 million.

Spencer Crowley stated other Counties' FWC and EPA approved Manatee Protection Plans, (i.e. Palm Beach), do not regulate transient slips because they provide an opportunity for the vessel to stop and visit a park, which reduces the risk to the Manatee. Consistent with the MRC's 3/6/24 resolution, in support of the City's presented plans the MRC will continue supporting the City of Miami's appeal in order to permit the completed construction engineering documents.

#### IV. New Business

The public meeting adjourned.



#### **FORT DALLAS**

Fort Dallas was built in 1844 as slave quarters in the William English plantation located on the north bank of the Miami River's mouth. It is built from oolitic limestone quarried at that site. After English left for the 1849 California gold rush, the Army reopened "Fort Dallas" on the site in preparation for the 3rd Seminole War.

Subsequent uses of the building were a trading post, the County courthouse, post office and a tea room. A plan to destroy the building in 1925 rallied the community. By agreement with the City of Miami, it was disassembled and re-built in Lummus Park.

#### **WAGNER HOMESTEAD**


This pre-1858 structure is the county's oldest standing house. It was built by William Wagner, an 1855 pioneer, whose homestead included a coontie mill and Miami's small wooden church, which burned down in 1892.

The Dade County pine house is a hand-hewn, peg fastened and woodshingled example of mid-19th century shelters.

Development in the 1920s prompted its donation to the Dade Heritage Trust, a private preservation group who undertook relocation and restoration. The City Commission designated the Wagner Homestead a historic site in 1984.



Fort Dallas & Wagner Homestead



As you know, I always take the time to respond to you. And while all of my responses may not be by email, I always take the time to make certain that you receive a response from me.

In your email message below, you attached it to an email message from March 2, 2023, as if you had not received any response from me for the past nine (9) months. Our exchange of email messages in March dealt with your request, or more appropriately, the Miami River Commission's request, to utilize certain properties that are owned by Miami-Dade County for the annual Miami Riverday event, which takes place along the Miami River, and which was then scheduled to be held between March 31 – April 1, 2023. And at that time, based upon your request, I placed you in contact with the appropriate Miami-Dade County staff to allow the Miami River Commission to utilize the properties that it wanted to have access to for both stagging and parking. Thank you for your email message.

Please allow me to take this opportunity to share with you what Miami-Dade County is currently planning for the subject parking lot. The parking section of the Internal Services Department has agreed to undertake the responsibility of managing and otherwise operating the parking lot on behalf of the Water and Sewer Department, which is the department, within Miami-Dade County, that controls the parking lot.

As you might imagine, the parking section has a lot of experience managing and otherwise operating parking lots and parking garages. And based upon such experience, it makes perfect sense for the parking section to undertake the responsibility of operating and otherwise managing the subject parking lot. The current plan involves operating the parking lot with a parking machine/meter, to limit the overall operating expenses, because the cost to have a parking attendant on site, 12 to 15 hours per day, every day, is expensive.

Unfortunately, due to an odd twist of fate, the parking section must first secure the approval of the Board of County Commissioners, because of a technical issue, the likes of which I will spear you of. The next opportunity to have an agenda item, for the Board of County Commissioners, which will resolve the technical issue, is in September, two (2) months away. In the interim, my office had hoped to negotiate a temporary agreement with a restaurant located near the parking lot, which would have allowed the restaurant to open and utilize the parking lot, but the restaurant owner has not been receptive to responding to Miami-Dade County, so that expected interim solution was recently abandoned. As a result, it appears that we are two (2) months away from opening the parking lot to the public.

Separately, and completely unrelated to the aforementioned matter, I noticed in the email chain below that not all of the correspondence that we have exchanged is included. For example, I sent you an email message on June 30th, which cannot be found below.
